

ADMISSION POLICY - September 2021

SS Simon and Jude Church of England Primary School is an academy. The Academy Trust is the admission authority for the school, and the school is required to act in accordance with the School Admissions Code. The admissions process is co-ordinated by Bolton Council (the Local Authority) and the school liaises with the Local Authority and with Manchester Diocese on admissions issues. The following arrangements for admissions include the criteria used to determine the allocation of places when the school is oversubscribed.

Admission arrangements

The school's published admission number (PAN) agreed for admission to the Reception year is 60. If no more than 60 applications are received for admission to the Reception year, all applicants will be offered places.

The school will admit all children having an Education, Health and Care Plan (EHCP) in whose EHCP the school is named.

Oversubscription criteria

When the number of applications received is greater than the number of remaining places available (after the admission of any pupils with an EHCP naming the school), the decision on which children will be allocated places will be based on the following oversubscription criteria, which will be applied in the order of priority set out below:

1. Looked after children and previously looked after children. (A "looked after child" is a child who is (a) in the care of a local authority, or (b) being provided with accommodation by a local authority in the exercise of their social services functions at the time of making an application to a school. Previously looked after children are children who were looked after, but ceased to be so because they were adopted (or became subject to a child arrangements order or special guardianship order).
2. Other children who are considered as "vulnerable" whose application for the school is supported by the Assistant Director for Social Care. This will include;
 - i. children for whom there is a child protection plan or has been within a 12 month period
 - ii. children who have had a period in care within 2 years of the admission application and are still receiving social care services.
 - iii. children who are considered to be at significant risk of becoming looked after.



- iv. children who are living in temporary accommodation due to fleeing violence and the area for rehousing has been identified.
3. Children who will have older sibling(s) in years Reception to Year 6 of the school at the time of application and date of admission. Sibling includes full, step, half, foster and adopted brothers and sisters living at the same address.
4. Children who have strong Church connections.
Parents must complete the supplementary form A attached to the application form as evidence that the family and the child are active worshipping members at the church to which the school is affiliated. Supplementary form B must also be completed by the vicar/designated church officer in order to verify the application.

SS Simon and Jude CE Primary School is affiliated to Seven Saints Parish New Bury with Great Lever (St Catherine's Church, New Bury; St Georges with St James, New Bury; St Michael with St Bartholomew, Great Lever and SS Simon and Jude Church, Great Lever.)

Active worshipping members of the church will be those persons who worship at least once a month sustained over a period of a year prior to the closing date for applications.

Variation for admissions in September 2021: In the event that during the period specified for attendance at worship the church has been closed for public worship and has not provided alternative premises for that worship, the requirements of these admissions arrangements in relation to attendance will only apply to the period when the church or alternative premises have been available for public worship.

5. Children who suffer from a medical condition or disability, or specific social need which makes it, better for them to attend this school rather than another. Places will only be offered under this criterion (medical) if the child has a certified medical condition with strong professional supporting evidence confirming that the condition exists. Medical evidence must be provided at the time of the application. Such evidence must set out the particular reasons why the school is the most suitable for the child and the difficulties that would be caused if the child had to attend another school.
6. Any other children, with priority given to those living nearest to the school (See geographical proximity (Where you live) tie-breaker below)



Tie-breaker

If the school is oversubscribed in any of the above categories, geographical proximity will be used as the tie-breaker. The distance will be measured in a straight line using Routefinder, a computerised mapping system which measures from the point on the highway nearest to the centre of the home property and the designated main entrance to the school.

Final Tie-breaker

If the distance from home to school does not distinguish between two or more applicants with equal priority for the remaining place, random allocation will be used as the final tie-breaker. This will be supervised by someone independent of the school.

Children from multiple births

Where a single place remains at a school and the application being considered is for twins (etc.) Bolton Council will allocate places to all those children. If places for both (all) siblings cannot be offered where the class size limit of 30 has been reached Bolton Council will use random allocation to allocate the remaining place(s). This may apply also to siblings who are in the same year group.

Applying for places

Applications for places in Reception in the normal admissions round each year must be made on the local authority's common application form. Details of all the applications made will be forwarded to the school by the local authority.

In addition to the local authority form, please complete and return the Supplementary Information Form (SIF) if you wish your child to be considered for entry under the faith-based criterion (criterion 4 above.)

Waiting list

Where we have more applications than places, the oversubscription criteria will be used to determine the allocation of places. Children who are not admitted will have their name placed on a waiting list. The names on this waiting list will be in the order resulting from the application of the oversubscription criteria. Since the date of application is not one of the oversubscription criteria, it cannot be a criterion for the order of names on the waiting list, and late applicants for the school will be slotted into the order according to the extent to which they meet the criteria. Thus it is possible for a child who moves into the area later to have a higher priority than one who has been on the waiting list for some time. If a place becomes available within the admission number, the child whose name is at the top of the list will be offered a place. This is not dependent on whether an appeal has been submitted. This waiting list will operate until 31st December at the end of the autumn term following admissions in September.



Appeals

Where the governors are unable to offer a place because the school is oversubscribed, parents will be informed of the reason why admission was refused and of their right to appeal to an independent admission appeal panel.

Parents wishing to appeal must set out their grounds for appeal in writing and must send the appeal to: Pupil and Student Services, Town Hall, Civic Centre, Bolton, BL1 1RU.

Deferred Admissions

Children are entitled to a full-time place in school in the September following their fourth birthday. Once they have been offered a place at the school, the child's parents can defer the date their child is admitted to the school until later in the school year but not beyond the point at which they reach compulsory school age and not beyond the beginning of the final term of the school year for which the application was made. Where parents wish, children may attend part-time until later in the school year but not beyond the point at which they reach compulsory school age.

Admission outside the child's normal age group

Parents may seek a place for their child outside of their normal age group, for example, if the child is gifted and talented or has experienced problems such as ill health. In addition, the parents of a summer born child may choose not to send that child to school until the September following their fifth birthday and may request that they are admitted out of their normal age group – to reception rather than year 1.

Parents requesting admission out of the normal age group must put their request in writing, addressed to the Headteacher at the school, together with any supporting evidence that the parent wishes to be taken into account. The governors will make decisions on requests for admission outside the normal age group on the basis of the circumstances of each case and in the best interests of the child concerned. This will include taking account of the parents' views; any information provided about the child's academic, social and emotional development; where relevant, their medical history and the views of a medical professional; whether they have previously been educated out of their normal age group; and whether they may naturally have fallen into a lower age group if it were not for being born prematurely. The governors will also take into account the views of the Headteacher. When informing a parent of their decision on the year group the child should be admitted to, the governors will set out clearly the reasons for their decision.



Where the governors agree to a parent's request for their child to be admitted out of their normal age group and, as a consequence of that decision, the child will be admitted to a relevant age group (i.e. the age group to which pupils are normally admitted to the school) the local authority and governors must process the application as part of the main admissions round, unless the parental request is made too late for this to be possible, and on the basis of their determined admission arrangements only, including the application of oversubscription criteria where applicable. The admission authority must not give the application lower priority on the basis that the child is being admitted out of their normal age group.

Parents have a statutory right to appeal against the refusal of a place at a school for which they have applied. This right does not apply if they are offered a place at the school but it is not in their preferred age group.

Non-routine/in-year admissions

It sometimes happens that a child needs to change school other than at the "normal" time; such admissions are known as in-year or non-routine admissions. Parents wishing their child to attend this school may arrange to visit the school. They will be asked to complete an application form and will be offered a place by the governors if one is available. The LA will be informed of the offer of a place once it has been accepted. If there is no place available in our school then the applicant will be informed in writing, together with the LA, and information about how to appeal against the refusal will be provided. Appeals for children moving into the area will not be considered until there is evidence of a permanent address, e.g. exchange of contracts or tenancy agreement with rent book. For children of UK Service personnel and other Crown Servants returning to the area proof of posting is all that is required.

Please note that you cannot re-apply for a place at a school within the same school year unless there has been relevant, significant and material change in the family circumstances.
